### **Minutes**

There was a motion by Paul, seconded by Bill to approve the minutes from August 2, 2012 as written. All were in favor.

### **Master Plan**

Outstanding items for the Master Plan are: Reformatting of the Matrix in Chapter 8, Place Holders, and further discussion of minutes from December 8, 2011. The board went over all changes from the Work Session Minutes dated December 8, 2011 and changed the Master Plan as they went along. Barbara will make copies of the draft Master Plan for the next meeting.

- Pg. 5 Mike Cauble's name should be listed first because he did so much work on the Master Plan.
- Pg. 15 Fourth paragraph, starting with Center Effingham was changed to read: 'Center Effingham boasts the Grange building where the Preservation society meets, and the Historical Society building. The historic Masonic Charitable Institute gave their building to be used as the town hall; it is now home to the Effingham Public Library and Masonic Lodge. Also located in Center Effingham is the town's main fire station.'

South Effingham was changed to read: 'South Effingham borders the state of Maine and contains a portion of Province Lake.'

A reference to Lord's Hill was added after 'Effingham Falls' and before 'Center Effingham'. It reads: 'Lord's Hill area contains many historic buildings including New Hampshire's first normal school.'

- Pg. 29 In the paragraph under 'Figure 5', delete the sentence 'The preparation and passage of a conservation subdivision ordinance may minimize the impacts of future development by reducing the amount of land that is impacted.'
- Pg. 38 In the heading 'Additional fire ponds/dry hydrants' add'/cisterns'. So the heading now reads: 'Additional fire ponds/dry hydrants/cisterns'

- Pg. 148 Sixth paragraph, delete the sentence 'The Conservation Commission contributed their Natural Resources Inventory, which became the chapter (number 7) on Natural Resources.'
- Pg. 17 First paragraph change the sentence 'The Conservation Commission was asked to assist on the Natural Resources Chapter it submitted the 2007 Natural Resources Inventory for consideration, and that document appears as Chapter 7 of the Master Plan.' to read: 'The Conservation Commission was asked to assist on the Natural Resources Chapter.'
- Pg. 17 First paragraph change the sentence 'The Conservation Commission presented their 2010 Action/Implementation Plan at that Public forum and that document appears as a Supplement at the end of Chapter 7.' to read: 'The Conservation Commission presented their 2010 Action/Implementation Plan at that Public forum.'
