#### **Public Comment**

Michael Cahalane of the Historic District Commission identified typo's in the Town Report and an outdated list of various committee members.

#### Fire Department

Chief Burbank informed the Selectmen the grant is approved for the HazMat Mitigation Plan. Chief is in the process of submitting for the Emergency Management Plan grant. With regards to the plans and securing the grants, Emergency Operations Center (EOC) must be certified. Selectmen Swanick and Slack need to become compliant by taking the National Incident Management System (NIMS) courses 100, 200, and 700 to become Incident Command System (ICS) certified for the EOC. All members of the Fire Department are certified. Unsure of the Police Department. ## Preservation of Endangered Historical Properties

Robin LeBlanc and Dave Jeffers from Plan N.H. met with the Planning Board. It was decided to apply for a Community Charrette. The date is to be determined. However, it will be on a Friday and Saturday Plan NH will hold a presentation. A charrette is an event designed for the purpose of discovery. It brings together a team of professional volunteers and community residents and leaders and provides a setting where, together, an exploration of needs and issues pertaining to the quality, condition, characteristics and use of the built environment within a town or village.

The intended outcome of each charrette has five points:

- 1. To initiate open discussion and consideration of the town and its needs.
- 2. To inform residents and leaders about what is happening in their community and to have a better understanding of the forces that affect its quality of life.
- 3. To use what is learned about the community, in conjunction with the expertise and experience of the Plan NH volunteers, to innovate a new vision of the community's resources and opportunities.
- 4. To develop a plan inspired by the new vision and composed of specific team recommendations.
- 5. To identify specific actions needed for the implementation of the plan.

Each year Plan NH selects five towns.

The timeline for 2012 is as follows:

Deadline for the Submittal of Applications: March 16, 2012.

Review of Applications: March 30, 2012.

Applicants Notified: April 2, 2012.

Charrette Dates: Between May 15 - September 30, 2012.

The Town would pay \$5,000 if selected. The Planning Board has a Land Use fund. The Historical Society could potentially contribute. Request letters from various boards supporting the revitalization effort. Paul Potter and others will speak to residents. Selectman Swanick made a motion to have Selectman Slack draft a letter of support. All Selectmen agreed. Motion approved.

## Discussion on Article 17

Selectman Meisner provided information. For a resident over the age of 60 a donation is requested. For a resident 59 and under, the following applies:

\$10 for "door to door"

\$10 for flex

\$5 for economy (day) pass

\$2 each way

Bus transportation would **only** run in Effingham on Tuesdays from 10-4. If "door to door" is requested, notification is required a few days prior.

From door to "flex" stop (Ctr. Ossipee). From "flex" stop it is \$2 each way.

#### Transfer Station

#### Tax Kiosk on Town Website
