"Number of travel trailers allowed on a lot: Discussion centered on the definitions between RVs and travel trailers and the number allowed on a lot without becoming a campground. Change to: 'Agricultural activities as described in Section 1605 that occur inside of or within 150 feet of an Exemplary Wetland'

Removal of 'Timber harvesting and'

#### Section 1705

Remove 1705 A, B & C

Change to read: 'Timber harvesting and forestry operations which (a) utilize best management practices as described in Best management Practices for Erosion Control on Timber Harvesting Operations in NH (Best Management Practices for Forestry: protecting New Hampshire's Water Quality, 2005; heep://extension.unh.edu/Forestery/Pubs/BMPBook.pdf); (b) comply with all applicable state laws are permitted use and do not require a special use permit.'

There was a motion by Paul, seconded by Bill, to accept all changes to Sections 1605, 1607 & 1705 of the Effingham Zoning Ordinance. All were in favor.

A hearing will be held on Wednesday, January 22, 2014 for:

- Steep Slope & Wetlands (sections 1605, 1607 & 1705)
- Map changes to the Lord's Hill Historic District
- Conflict of being in 2 districts
