- 8. What will be the average length of stay?
- 9. What is the longest anticipated stay?

10. Are there any suggestions to the PB that could aid your business (Site Plan Regs, Zoning Ordinance or other thoughts)?

- 11. Is there anything the Town can do for your facility?
- 12. Will the clients be voluntary or court ordered?
- 13. What kind of lease do you have and for how long?
