2020 Zoning Amendments

Nate Fogg will send out a reminder to be prepared to discuss sections of the Zoning Ordinance to be revised this coming year are: Section 605 (unregistered vehicles) is still a problem in town. Slapping a plate on an old vehicle should not be a way around the intent of the article. Section 702 (change of expansion of non-conforming use) Section A is clear, but it is unclear who can approve section B. Can the ZEO approve that type of expansion? Section 1023 (non-conforming structures) This section does not fit well in this section of the zoning ordinance. Section 1604 (buffers) The title of the Shoreland Water Quality Protection Act needs to be updated. The reminder will be sent out with the minutes from the August 1st meeting.
