#### **Cemetery Contract Agreement Ordinance**

Adopted in accordance with and under the authority of the New Hampshire Revised Statutes Annotated, Title XXVI: Cemeteries; Burials; Dead Bodies, Chapter 289.

After much research of existing plot fees of surrounding areas, it was determined by the Board to raise the Woodland Cemetery plot fee to \$350.00. Mr. Cahalane made a motion to accept the increase of plot fees effective July 21<sup>st</sup> 2020, Mr. Fuller seconded, all in favor.

## **Effingham Police Department & Fire Department Alarm Ordinance**

This ordinance was compiled from similar area ordinances

The purpose of this ordinance is to ensure efficient, responsible responses to emergency alarms and minimize the Town taxpayer expense related to responding to false alarms. As well as reducing any health and safety hazards as a result of responding to non-emergency calls for service. There will be penalties involved to those who transmit false alarms whether alarm systems, telephone, text, etc. The complete ordinance is available for viewing on the Town website or at the Town Office.

### No Through Trucking Ordinance

The Effingham Board of Selectmen's authority to adopt regulations is set forth in RSA 41:11 relating to regulation of the use of Town roads and RSA 47:17 VII and VIII which specifically authorizes the Selectmen to make regulations as to the use of vehicles upon particular highways and to exclude such vehicles altogether from certain highways.

The Board has identified roads in Effingham that would best be designated as "no through trucking" to preserve the deterioration and maintenance of these rural roads. Safety also played a factor, as many of these roads are residential in nature. The roads included in this decision are Champion Hill Road, Nutter Road, Molly Philbrick Road, School Street, Clough Road, Huntress Bridge Road, Granite Road, Bonnyman Road, Hutchins Pond Road and Wilkinson Swamp Road.

The ordinance in its entirety may be viewed on the Town website or at the Town Office.
